Council Meeting August 25, 2025

The Maysville Board of Aldermen met in regular session on Monday, August 25, 2025 at 6:00 pm pursuant to the Missouri Sunshine Law 610.021.

Mayor Ronnie Pearl called the meeting to order with the following members present: Clint Sollars, Darrell Conley, Amy Justus and Larry Zieber.

Also present were City Clerk Pat Fisher-Johnson and John Miller.

The meeting was called to order and Mayor Pearl led us in the pledge followed by a prayer from Alderman Conley.

Alderman Zieber made a motion to approve the consent agenda. Seconded by Alderman Justus. Motion carried. This included minutes of the August 11, 2025 meeting and the following checks: Water 6999-7010, Wastewater 3554-3561, Street 4493-4501, General 22079-22087, Pk 1241-1242, and Payroll 11037-11053.

John was present for his 90 day review. After discussion, Alderman Sollars made a motion to increase pay to \$21.50. Seconded by Alderman Justus. Motion carried. John will now be in charge of the city crew – Tony and the summer help.

City Clerk stated because we don't pay weekend help could we change our paydays back to Fridays. Board members were ok with this change.

Alderman Sollars reported the crew has replaced the front counter, boarded up the windows in the MG building, put a tube in on Railroad Street, have done maintenance on the equipment, fixed the dog kennel, replaced a tube on Camden, and mowed.

Alderman Sollars presented a list of items/projects that are in the works or need to be in the works.

The Board discussed the fire department and the water usage once connected to the GNWWW line. City Clerk will get board members names and report back.

The Board discussed putting the use tax on the April Ballot. Clerk was asked to get some marketing material for the board to review.

The board discussed applying for a grant for the parks. This grant is a matching grant to include in-kind. The Board agreed to apply for \$75,000.

The board appointed City Clerk to the MO-Kan Regional Council board.

The board set the following dates for clean up around the square for Sept 4 at 5:00 pm with a rain date of Sept 10th also at 5pm if anyone would like to help.

Alderman Justus made a motion to go into closed session to discussion for personnel. Seconded by Alderman Zieber. Roll call vote: Sollars – yes, Justus – yes, Conley – yes and Zieber – yes. Motion carried.

Alderman Conley made a motion to go back into open session. Seconded by Alderman Justus. Roll call vote: Conley – yes, Zieber – yes, Sollars – yes and Justus – yes. Motion carried.

The Board signed the AOE with DNR. If we follow all recommendations, there will be no more additional issues.

The board did the 90-day review for John Miller. John did ask the board if he could change his hours from 7 am to 3 pm so he and his wife could ride together if she gets her job in town, board agreed.

Alderman Sollars made a motion to raise John's rate of pay. Seconded by Alderman Justus. Motion carried.

The board agreed to move board meetings back to Wednesdays, but there will only be one meeting in September due to conflicting schedules and Country Harvest activities.

With no further business, Alderman Zieber made a motion to adjourn. Seconded by Alderman Conley. Motion carried.

The meeting was adjourned at 8:15 pm and the next meeting will be September 17th at 6:00 pm.
