

Council Meeting
October 27, 2025

The Maysville Board of Aldermen met in regular session on Monday, October 27, 2025 at 5:30 pm pursuant to the Missouri Sunshine Law 610.021.

Mayor Ronnie Pearl called the meeting to order with the following members present: Clint Sollars, Darrell Conley, Amy Justus and Larry Zieber.

Also present were City Clerk Pat Fisher-Johnson, Stephanie Ayres, Casey Flinn, Aspen Ginther, Tanya Zimmerman and TH Bosler.

The meeting was called to order and Mayor Pearl led us in the pledge followed by a prayer from Alderman Conley.

Alderman Justus made a motion to approve the consent agenda. Seconded by Alderman Conley. Motion carried. This included minutes of the October 14 2025 meeting and the following checks: Water 7053-7057, Wastewater 3586-3591, Street 4534-4542, General 22132-22137, Pk 1253-1256, and Payroll 11096-11139.

Tanya was present to see if the city could assist at getting down some items from Candy Cane Lane so they can be painted and possibly lights put on them. The guys will take down and set beside her garage so they can be painted. Tanya is also going to see about getting banner to go across the highway – may be next year but going to check into it.

Casey reported that things were going good at the plant and whenever we get the two inch meters in, they would change them out. Stephanie is going to call the school and make arrangements to change the first two out. The city guys have changed or replaced about 10 meters that were in need of replacement. Casey said they couldn't make the connection to the water line until testing of the line was complete then it should take his guys less than a week to make the connection.

The city will not be able to be connected to the new water line by November 1st as hoped for due to the treatment of the line and the government shut down.

City clerk will call other cities and get their connection water ordinance so TH can draft the city a new one.

Alderman Sollars made a motion to go into closed session. Seconded by Alderman Conley. Roll call vote: Zieber – yes, Conley – yes, Justus – yes and Sollars – yes. Motion carried.

Alderman Zieber made a motion to go back into open session. Seconded by Alderman Justus. Roll call vote: Justus – yes, Sollars – yes, Zieber – yes and Conley – yes. Motion carried.

Alderman Sollars gave a report from the crew: Salter is tested and ready to go, need to get prices for a second salter, pipe racks are built, City Hall sidewalk is repaired, started wiring the street shed, replaced meters, and set up to test other meters, and ordered more patching material.

Alderman Zieber asked to get some patch on Atchison where it connects to the square on Jackson.

The board agreed to expend open burning until end of November.

The board agreed City Hall could close at 3 on Halloween to join the activities on the square.

City Clerk reported she has sent out the lead letter to the customer that reported they had lead lines.

City Clerk will check on our holiday dinner and get it scheduled.

Alderman Justus stated she would like to get a Holiday Decoration to put up at the water plant – she will get prices and report back.

With no further business, Alderman Zieber made a motion to adjourn. Seconded by Alderman Conley. Motion carried.

The meeting was adjourned at 7:10 pm and the next meeting will be November 10th at 6:00 pm.
