

Council Meeting  
October 14, 2025

The Maysville Board of Aldermen met in regular session on Tuesday, October 14, 2025 at 6:30 pm pursuant to the Missouri Sunshine Law 610.021.

Mayor Ronnie Pearl called the meeting to order with the following members present: Clint Sollars, Darrell Conley, Amy Justus and Larry Zieber.

Also present were City Clerk Pat Fisher-Johnson.

The meeting was called to order and Mayor Pearl led us in the pledge followed by a prayer from Alderman Conley.

Alderman Justus made a motion to approve the consent agenda. Seconded by Alderman Zieber. Motion carried. This included minutes of the September 17 2025 meeting and the following checks: Water 7011-7052, Wastewater 3576-3585, Street 4502-4533, General 22087-22131, Pk 1243-1252, SW Check #1577, Covid Check #1515 and Payroll 11054-11095.

The mayor reported he has talked with Mo-Dot about the water issue at Victory Lane. There was also discussion about the parking strips on the south side of the square and who was going to repaint them. Clerk will see what she can find out.

The Board had discussion about the food trucks coming to town – no action was taken.

Alderman Justus made a motion to go into closed session to discuss personnel. Seconded by Alderman Zieber. Roll call vote: Zieber – yes, Conley – yes, Sollars – yes and Justus – yes. Motion carried.

The city crew should work on projects inside City limits and work on outer projects as time allows.

Alderman Zieber made a motion to go into open session. Seconded by Alderman Conley. Roll call vote: Zieber – yes, Conley – yes, Justus – yes and Sollars – yes. Motion carried.

Alderman Sollars gave a report from the crew: Worked on Offutt ditch, replaced tube on Dallas & King, worked on 3-meter issues, put gravel on Willow Brook, worked on Archery Range, cleaned bathrooms at parks, took down a tree behind the lake, worked on Archery range along with their other weekly items.

The Board agreed once the Archery range is complete there will be a ribbon cutting and a photo opt.

The board reviewed a bill presented to the city from work done by the township. After much discussion, no action was taken to pay the bill because it was fixed before we knew how much.

City Clerk will talk with attorney about code enforcement and how we should handle this process now that Jennifer has retired.

Alderman Conely made a motion for City Clerk and Deputy Clerk to attend Regionals in Belton on November 5<sup>th</sup>. Seconded by Alderman Zieber. Motion carried.

The board discussed cleaning the bathrooms more frequently. City Clerk will make contact with the cleaning lady that cleans City Hall to see if she would be willing to clean the bathrooms at Bartlett Park on Tuesday and Fridays.

The Board reviewed the bids for tree logging around the lake. After discussion, Alderman Justus made a motion to accept the bid from Austin Cochran for 50/50 and 15 cent per pallet foot on other logs. Seconded by Alderman Sollars. Motion carried.

The board agreed to participate in the Country Harvest trick or truck on October 31<sup>st</sup>. City Clerk will purchase the candy bars to hand out.

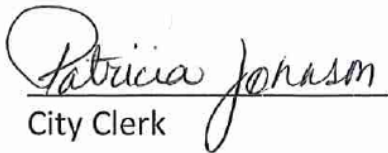
Reminder of Fall Clean up on October 25<sup>th</sup> at the water plant from 7 to 12pm.

City Clerk will put winter salt and holiday dinner on the next agenda.

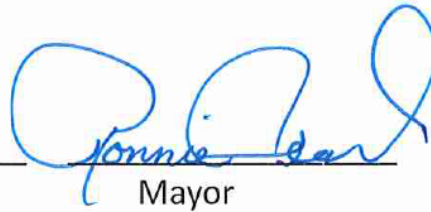
With no further business, Alderman Zieber made a motion to adjourn. Seconded by Alderman Justus. Motion carried.
